**Deposit & Payments:** The following deposit is required to secure confirmed accommodations. Deposit will be charged at time of reservation. Balance of cruise is due by May 15, 2011. Payment can be made by American Express, Visa, MasterCard or Discover. Final Payment will be charged automatically on May 15<sup>th</sup> to the same credit card used for deposit. Please notify DreamMaker if you need to use a new credit card for final payment.

Cancellation & Refunds: For most cruises and tours, a full refund (except for amounts paid for Vacation Protection Plan) will be made for written cancellations received by Holland America Cruise Lines at least 75 days before the date on which you are to commence travel (by air, rail, sea or otherwise). Passengers, who cancel after that date for any reason, including medical or family reasons, are subject to the following per-person cancellation fees: per person

Given that the resales of cancelled space will likely result in a lost opportunity to sell other space, these fees are due regardless of resale. Fees incurred as a result of cancellation cannot be applied to future bookings. Name changes require the prior approval of Holland America and may not always be possible. Cruise and Cruise Tour Contracts are nontransferable. Name changes and departure date changes are considered reservation cancellations and are subject to cancellation fees.

Cruise Rates: Government taxes and fees are included in the cruise rate above. Airfare is additional. Taxes on airline transportation, air transportation, shore excursions, medical services and items of a personal nature—such as bar beverages, gift shop purchases, beauty salon/ barber shop & massage services, gambling and service/porterage gratuities-are not included in the cruise rate. The amount of taxes and charges specified herein are subject to change. Holland America reserves the right to pass through to the guests any increases which become effective after the printing of the brochure.

**Liquor Policy:** Holland America is sorry but guests are prohibited from bringing alcoholic beverages of any kind on board the ship for consumption. Alcoholic beverages purchased in the ship's gift shops or in foreign ports will be retained by Holland America until the end of the voyage. You may purchase mixed drinks and other beverages from any of the ship's bars and lounges. Alcoholic beverages will not be sold or served to anyone under the age of 21. Holland America reserves the right to refuse the sale of alcoholic beverages to anyone.

**Clothing:** Casual attire is in order during the day. For two nights, a dark suit or formal attire is suggested. The dress code for the remaining evenings should be a sport coat and tie to casual resort wear.

Passport Data: US Immigration determines the correct documents, which guests must have in their possession in order to travel. Proper travel documentation is required throughout the cruise and is the responsibility of the guest. Any guest traveling without proper documentation will not be allowed to board the vessel and no refund of cruise fare will be issued. Documents must be presented at time of embarkation. All non-US citizens must surrender their passports and/or green cards and these documents will be returned at Immigration upon arrival back in the US. US and Canadian guests need proof of citizenship (Passport). Resident Aliens need both a passport and an Alien Residents Card. Aliens need a valid passport and a valid unexpired US multiple Re-Entry Visa. Aliens eligible to apply under Visa Waiver Program must have a valid unexpired Passport.

**Minor Guests:** Guests under the age of 21 years must be accompanied by a parent, grandparent, or guardian 25 years or older in the same stateroom. Infants must be at least 4 months old to be eligible to travel. Holland America offers supervised activities for children 2-15 with limited activities available for 16-18 year olds.

Responsibility: DreamMaker Travel neither controls, nor operates, nor is responsible for the actions of independent Contractors such as cruise lines, airlines, railroad companies, tour operators or ground transportation. You are responsible for arriving at the respective ports on time for embarkation and for joining the vessel at its next port of call if for any reason you miss a scheduled sailing. Holland America reserves the right to refuse or discontinue passage to anyone when in Holland America's judgment; it would be considered a risk to the guest's own safety and well-being or the health, safety, well-being comfort and enjoyment of any other guest or crewmember.
